SAFETY TRAINING

PROTECT WATCH FIRE WATCH WITH HANDS-ON FIRE EXTINGUISHER TRAINING

Place: Three Rivers Safety Center, 1615 W. Jefferson Street, Joliet, IL
Time: 7:00am to 7:30am Registration; 7:30am to 10:00am Training
Cost: \$ 65.00

Who Should Attend: Any employee who will be assigned to a fire watch job; maintenance and safety personnel.

Class Size: The maximum class size is 25. Please spread the scheduling of your employees between the available class dates to assure adequate availability.

Description: This course provides hands-on fire extinguisher practice using the Pyrosoft Fire Simulator developed by Pyrosoft Inc. Pyrosoft's portable fire simulators teach students how to properly assess fire hazards and extinguish them without ever lighting a real fire. Using Pyrosoft's Classroom multimedia training tools, they learn the basic elements and classes of fire. This course also covers the responsibilities of the fire watch, OSHA requirements and the use and application of various fire extinguishers.

Badge Requirements: Successfully complete course; Pass written exam with a minimum score of 70%

PROTECT WATCH CONFINED SPACE TRAINING

Cost: \$ 25.00

Who Should Attend: Any employee who will be assigned to a confined space entry watch job; maintenance and safety personnel.

Class Size: The maximum class size is 25. Please spread the scheduling of your employees between the available class dates to assure adequate availability.

Description: This course prepares contractor employees to execute the stringent procedures for ensuring the safety of individuals working in confined spaces. Examples include:

- Process vessel
- Enclosed storage areas for hazardous materials
- Railroad tank cars
- Areas with limited entry or exist

This training also includes establishing rescue procedures for workers who are overcome or injured in a confined space.

Badge Requirements: Successfully complete course; Pass written exam with a minimum score of 70%

PROTECT WATCH SUPPLIED AIR TRAINING

Cost: \$ 35.00

Who Should Attend: Any employee who will be assigned to a breathing air - bottle watch job; maintenance and safety personnel.

Class Size: The maximum class size is 25. Please spread the scheduling of your employees between the available class dates to assure adequate availability.

Course Description:

This course prepares contractor and all employees to safely execute the stringent procedures related to the duties and responsibilities of the breathing air and bottle watch attendant. Examples include:

Duties and Responsibilities

- Understanding IDLH Atmospheres
- Airlines and hoses
- Respiratory Protection Requirements
- Reviewing the Fresh Air Permit
- Know Your Equipment and all Components
- Required Bottle Pressure
- Common air source systems
- Required Pre-Job Safety Meeting
- Air supply system cascade or compressor
- Emergency Response Duties
- Bottle Watch Proximity

Badge Requirements: Successfully complete course; Pass written exam with a minimum score of 70%
